As this is the first Board Communique for the year, I would like to acknowledge the traditional owners of the land on which we teach and learn, the Ngunnawal people - and recognise any other people or families with connection to the lands of the ACT and region. In February 2024, the CIT Board began consideration of our third Reconciliation Action Plan for CIT, which aims to strengthen our shared journey of reconciliation and understanding with our First Nations students and staff.

I warmly welcome our students and I hope that through your time with CIT you learn the skills you need through your careers, perhaps even build a passion for lifelong learning. It was great news that the fee-free TAFE initiative was extended, allowing CIT to continue supporting students with 600 fee-free places available each semester. It was also fantastic news to secure funding to support the feasibility of a future energy skills hub at Fyshwick and a proposal to the Commonwealth that a centre of excellence be established at CIT Fyshwick to train more EV automotive technicians and to support the electrification of the economy. CIT has ambitions to grow across our five campus precincts, all of which have their vital role to play to strengthen Canberra's future growth and prosperity.

Whilst there are still headwinds to manage, these do not diminish in any way the pride we all share in CIT's ongoing achievements and success delivering high quality teaching and learning experiences for our community, nor do they inhibit our plans to continue strengthening our governance and grow together into an exciting future.
