### **Justice of the Peace** Non-Accredited Training

The Justice of Peace course equips you with the essential skills and knowledge needed to fulfill the duties of a Justice of Peace in the ACT. This includes understanding and applying relevant legislation, rules and codes of practice that govern their responsibilities.

Justices of the Peace in the ACT play a crucial role in the community by administering oaths and affidavits, witnessing statutory declarations, affirming declarations, witnessing signatures and attesting and certifying documents required by law.

You must first apply to become a Justice of the Peace through Access Canberra and have in-principal agreement to your appointment as a Justice of the Peace in the ACT from the ACT Attorney General.

Only applicants approved by the Justice and Community Safety Directorate are eligible to enrol in this course.

### JOB OPPORTUNITIES

Completion of this course will enable the successful participant to apply for membership of the ACT Justice of the Peace Association. Successful completion of this course is a recommendation to the ACT Justice and Community Safety Directorate that participants are eligible to be sworn in by the Supreme Court of the ACT as a Justice of the Peace in the ACT.
