

# **GPG – Women in Renewables Scholarship 2025**

## **Application Form**

### **CLOSING DATES**

Applications for the first round of the scholarship must be received 11:59pm on **Monday, 30 June 2025**.  
Applications for the second round of the scholarship must be received by 11:59pm on **Thursday, 29 August 2025**.

The Global Power Generation (GPG) Women in Renewables Scholarship provides an opportunity for women to undertake training in renewable energy and allied fields at CIT to enable them pursue job opportunities in the renewable energy industry.

Six scholarships will be offered in the first round and another six scholarships in the second round to women who wish to study and obtain any of the following qualifications at Canberra Institute of Technology:

- Certificate III in Electrotechnology Electrician – UEE30820
- Certificate III in Air Conditioning and Refrigeration – UEE32220
- Certificate III in Electronics and Communications – UEE3092
- Certificate IV in Cyber Security – 22603VIC
- Certificate IV in Information Technology – ICT40120
- Diploma of Project Management – BSB50820
- Certificate IV in Project Management Practice – BSB40920

*Note:* Some courses require a minimum number of enrolments to run.

GPG Women in Renewables Scholarships are awarded to women students who demonstrate a commitment to study and to the environment. The scholarship will cover CIT student fees for the recipient to the value of up to \$3,300 or the full tuition, whichever is less for the duration of the study for the qualification or a maximum of three years, whichever is lesser. Fees will be refunded upon successful completion of each unit of study at the end of the semester and credited to the student's account. For trade courses, scholarship money may also be used to purchase recommended tools and equipment for their training, with funds credited to the student's account upon production of receipts as evidence of purchase. In addition to the training, for scholarship recipients that are not apprentices, there are possible work placements with renewable energy companies and mentoring by renewable energy industry experts following satisfactory interviews and completion of at least one semester of study.

Global Power Generation (GPG) is the Naturgy Group subsidiary dedicated to international power generation. GPG develops and manages generation assets with a global approach, and offers development, construction, operation and maintenance services for its facilities. GPG operates in eight countries and has assets across wind, solar and hydro power as well as battery storage. Within Australia, GPG currently have operational assets in ACT, NSW, VIC and WA. Expansion into Queensland is underway..

## Terms and Conditions for GPG Women in Renewables Scholarship Applicants

The GPG Women in Renewables Scholarship provides annual scholarships to Canberra Institute of Technology (CIT) students.

### 1. The Scholarship structure:

- The value is \$3,300 per scholarship to directly contribute to CIT student fees across the period nominated above. The funding may also be used to purchase tools or equipment to facilitate the student's training.
- It is available to full and part time female students enrolling in one of the eligible CIT qualifications in Semesters 1 and 2 in 2025.
- The length of the scholarship is six semesters up until the end of Semester 1, 2028, or upon completion of the qualification whichever comes first.
- Scholarships are awarded to worthy applicants who, at the absolute discretion of GPG, have fulfilled the selection criteria.

### 2. To be eligible for a Scholarship, applicants must:

- be female students 17 years or older. Mature aged female students are encouraged to apply.
- be Australian citizens or have permanent Australian resident status.
- all women can apply. However, preference will be given to those living and/or working in the ACT.
- be enrolled or intending to enrol in one of the eligible CIT qualifications starting in either Semester 1 or 2, 2025.
- be committed to complete the nominated qualification at CIT before the end of Semester 1, 2028.
- not hold any other scholarship valued more than \$500 in total at the time of application.
- be committed to participate in outreach activities as an ambassador of the CIT renewable and future energy program for the duration of the scholarship.
- provide evidence of:
  - i. a commitment to study; and
  - ii. commitment to the renewable energy and/or the sustainability industries.

### 3. Administration of Scholarships:

- Shortlisting of eligible scholarship recipients will be conducted by a selection panel.
- The panel will assess shortlisted applicants and then forward recommendations to GPG, who will approve recipients to receive scholarships. GPG's decision is final.
- CIT will notify all applicants, in writing, of the outcome of their application.
- The scholarship amount will be paid to the recipient in instalments after successful completion of each unit of study.
- All information supplied to panel members, Student Services and Administration Officers and GPG is treated as confidential.
