The Board continues to be fully engaged regarding campus renewal, particularly as we grow our capacity to work effectively with the Major Projects Canberra Woden CIT development team through the design stages. Staff and teacher input into this process is crucial, so thank you for the investment of your time in an exciting future.

The Board is also excited about the potential opportunities for CIT Fyshwick to update and upgrade facilities as part of the East Lake Urban Renewal. Demand is strong in our region's economy across the trades and capacity to support the needs of industry needs to grow.

The CIT is currently working to deliver a 'right-sized' team to support the implementation of the Strategic Compass. With this team, the Board has emphasised the importance of insourcing to grow capacity within CIT and to reduce reliance on consultants.

Having a right-sized executive means CIT finally has the capacity to implement efficient, supported business processes. This in turn will help to reduce the complexity and workloads staff and teachers continue to experience with outdated systems.

Critical to the work of CIT is ensuring that we are meeting the needs of not just students but of employers and the broader ACT community.
